INTEREST RATES and INTEREST CHARGES:	
Annual Percentage Rate (APR) for Purchases, Cash Advances, & Balance Transfers	18.00 % This APR will vary with the market based on the preceding 4 Week average of the 26 Week Treasury Bill.
Paying Interest	Your due date is at least 21 days after we mail your billing statement. We will not charge you interest on purchases if you pay your entire new purchase balance by the due date each month. We will begin charging interest on cash advances and balance transfers on the date the cash advance or balance transfer is posted to your account.

Penalty Fees - Late Payment: - Over-the-Credit Limit: - Return Loan Payment:	Up to \$25 the first time your payment is late 10 days after the statement cycle date. If you make a subsequent late payment within the following 6 billing cycles, you will be charged up to \$35 for each late payment. None \$30.00 if your payment is returned unpaid for any reason.

How We Will Calculate Your Balance: We use a method called "average daily balance (including new purchases)."

Minimum Payment Requirement: 2% of the outstanding balance at the end of the billing cycle or \$10.00, whichever is greater.
